BEHAVIORAL AGREEMENT

Dear Parents,

The goals of French Creek Bible Conference Association are to facilitate the training and growth of our covenant young people and to protect them physically, as well as spiritually. For that reason, we have taken a close look at the rules of our conferences, and we have revised them to continue to provide for the health, safety and welfare of the campers in light of the situations which exist in the world around us. We ask that you carefully and prayerfully consider the role which you play in this undertaking and work with us to keep French Creek a place of learning, growth and safety.

CHRISTIAN STANDARDS OF CONDUCT, AS OUTLINED IN THE INFALLIBLE WORD OF GOD, are expected throughout the entire slate of conferences. Furthermore, please be advised that the administrative rules and regulations promulgated specifically for the conferences and approved by the Board of Trustees of the French Creek Bible Conference Association are also in effect at all times throughout the conference as a concern for the health, safety and welfare of the campers. Please review with your child the rules and regulations listed below and on the reverse. If you have any questions or concerns regarding this document, please first contact the director of the appropriate conference and then the Board of Trustees for further information and/or direction.

RULES AND REGULATIONS FOR THE FRENCH CREEK BIBLE CONFERENCES

1. Clothing must reflect Christian standards of decency and modesty, and must not be inappropriate or distracting to the spiritual environment of the conference. Clothing should also be appropriate for a group camping environment:
 - Clothing which inherently may be considered revealing or immodest will not be permitted.
 - Clothing which is worn in an inappropriate or revealing manner will not be permitted.
 - Clothing (including accessories) which is imprinted with anything that may be considered disrespectful or inappropriate for a Bible conference will not be permitted.
 - The final decision on the appropriateness of dress will rest with the Conference Director.
2. No smoking, drugs, alcohol, or pornographic material is permitted during the conferences.
3. Firearms (including BB/pellet guns, paintball markers and Airsoft guns), knives or any dangerous or harmful device are not permitted.
4. Follow the conference schedule.
5. Be on time and attend all activities except when excused by the Nurse or Conference Director (Counselors do not have authority to excuse).
6. Keep in touch with Counselor and follow all direct and reasonable requests which may be given by the adults in charge.
7. Remain on conference grounds unless part of scheduled activity, or unless permission is granted by the Conference Director.
8. Hiking is done only with Counselors or staff members and only with the permission of the Conference Director.
9. Couples will refrain from public displays of affection and must remain with the group at all times.
10. Water activities are only at scheduled times. In addition, campers are expected to observe all rules posted by the pool management.
11. Visits to cabins of members of the opposite sex or to cabins in other units are not permitted.
12. No raiding of cabins is permitted.
13. Skits and songs shall be appropriate to the conference.
14. Assist in duties, such as table setting, as requested.
15. Cooperate in maintaining the cleanliness of the buildings and grounds.
16. Take care of and protect plant life, grounds, and park property.
17. Campers must observe the established curfew - Taps means lights out and quiet.
18. Campers must observe Sunday as a Sabbath to the Lord. There will be no recreation, baseball, or swimming on the Sabbath day. There will be no sales, except of meals to guests. There may be planned activities on Sunday afternoon.
19. Unless specifically authorized by the Conference Director, the use of items, such as electronic devices, comic books or water balloons, are prohibited because they might conflict with the purpose or program of the conferences.
20. All cell phones must be powered off for the duration of the conference and may only be used with specific permission by the Dean or Conference Director.

Any infraction (depending on the degree of severity and/or the chronic nature of the offense) can result in disciplinary action as follows:

1. Restriction of privileges (e.g. cabin restriction, work detail, etc.) or any other reasonable consequence as determined by the conference director.
2. Parental notification.
3. Return of camper to his/her home via parent-provided transportation, with no refund of fees.

NOTE: Any camper sent home for disciplinary reasons from one conference may not return to any age-appropriate conference for the duration of that year's conference schedule. In addition, any camper sent home from a conference for disciplinary reasons may not attend another conference in any capacity, in a subsequent calendar year, without a written recommendation from his/her Session.
